- K. Excluding witnesses from a hearing. (Tex. Govt. Code Sect. 551.084)
- L. Telephone consultation with the Board's attorney. (Tex. Govt. Code Sect. 551.129)

M. Discussion or adoption of individual assessment instruments or assessment instrument items. (Education Code Sect. 39.030(a))
