A Summary of the September 21, 2020 Palestine ISD Board of Trustees Regular Meeting

The Board of Trustees of the Palestine Independent School District held a Regular Meeting on September 21, 2020 at 6:00 PM, at the Palestine ISD Administration Office, located at 1007 East Park Avenue, Palestine, Texas 75801.

Call to Order

Meeting called to order by President Kurt Herrington at 6:05 PM.

Spotlight

Larissa Loveless, Director of Public Relations, introduced the spotlight portion of the meeting. The following students were recognized and a video presentation highlighting the accomplishments of each student was shown:

Public Comment

Matt Symmank, PISD Parent, spoke regarding his desire for the district to return to a 5 day week for students.

Superintendent's Report

Superintendent Jason Marshall reported on the start of the 2020-21 School Year:

- Extracurricular Activities (Cross Country/Volleyball/Football in District play. Districts must forfeit games that cannot be played due to COVID.)
- COVID-19 Update (District COVID cases have slightly increased/still minimal)
- In-Person/At-Home Learning Student Count:

Estimate: 82.3% In-Person Learners/17.7% At-Home Learners

- Student Enrollment on Day 29: 3,378 (Previous School Year Day 29 Enrollment: 3,411)
- District Update provided at Staff Breakfast/Lunch on September 25, 2020

Financial Report

David Atkeisson, Chief Financial Officer, presented a Financial Report. Mr. Atkeisson shared the following information:

- Tax collections were behind during the previous months, possibly due to COVID effects on the economy. Tax collections had begun improving recently.
- District is in the process of submitting a reimbursement request to the state for COVID-19 expenditures that had been incurred by the district.

Auditor Engagement

David Atkeisson, Chief Financial Officer, informed that a new audit firm would be needed for the 2020-21 school year due to having received notification that the previous auditor; Smith, Lambright & Associates would no longer be conducting school audits. The firm of Pattilo, Brown, and Hill (PB&H) of Waco, Texas provided a quote in the amount of \$33,500 and the district received good references for PB&H from other school districts. Mr. Atkeisson informed that although the quote contained pricing for multiple years, his recommendation was to engage PB&H to perform the fiscal audit for the year ending August 31, 2020; then at the conclusion of the audit the district can then determine whether to pursue a multi-year agreement. The Board approved the firm of Pattilo, Brown, and Hill (PB&H) to conduct the district's financial audit for year ending August 31, 2020.

The Fridays in which no students were at school provided teachers with time to prepare for both In-Person and At-Home students, and teachers had expressed an interest in adding some additional Fridays for At-Home Learning to the calendar. The Board discussed the information and reached a consensus to extend Friday At-Home Learning through Friday, November 13, 2020.

The Board discussed plans for the Texas 87th Legislative Session.
