## **Construction Projects Update**

Jeff Edwards of Claycomb Associates, Architects provided the Board of Trustees a construction update for Palestine High School. Installation of food service equipment in the kitchen and serving areas is complete and is being tested. Stage rigging, equipment, and lighting is being installed in the auditorium area. All of the roof systems are nearing completion. Overall, the PHS project is 86% complete.

# **Financial Report**

David Atkeisson, Chief Financial Officer, stated that the District has received 73% of projected revenue and has only expended 58% at this time. The District has collected 94% of property taxes which is an increase from last year at this point in the year. Interest earned on investments is \$20,000 ahead from last year. Principals and directors have shown good fiscal responsibility which is good news for the budget.

The Board of Trustees approved the addition of Superintendent Jason Marshall as an authorized representative for LOGIC Participant Services, Texas DAILY Client Services, Texas CLASS, TexSTAR Participant Services, and TEXPOOL Participant Services.

Buford Thompson Construction Company was approved as the construction company for the Design-Build Projects. These projects include renovations to the Palestine High School vocational building. Also to be considered if funds are available; are renovations at the Northside and Southside campuses, a PHS softball field, and additional football stadium parking.

# **Policy Revisions**

The Board of Trustees adopted of resolution to suspend the portion of District Local Policy EIA regarding the End of Course 15 percent provision for the 2011-2012 school year.

The Board of Trustees approved Local District Update 93, affecting local policies FFH (Local) and FFI (Local) in regards to student welfare, freedom from discrimination and freedom from bullying.

A revision to Policy CH (Local) affecting purchasing and acquisition was approved. The District's purchasing authority will increase from \$25,000 to \$50,000. This revision was recommended so that legal and local policy indicate the same amount for purchase of goods and services.

# **Superintendent's Report**

Superintendent Jason Marshall informed the Board that the District's enrollment as of April 16, 2012 is 3,174.

An Employee Appreciation Lunch on the Grounds will be held on May  $21^{st}$  at Palestine Middle School. A Baccalaureate Service will be held for Palestine High School seniors on Sunday, May  $20^{th}$ , 3:00 pm at Evangelistic Temple. Graduation will be held on Friday, June  $1^{st}$  at Wildcat Stadium.

Superintendent Jason Marshall gave an update on the public school finance lawsuit that calls on the Legislature to treat all Texas taxpayers and public school children fairly as required by the Texas Constitution. Originally, there were five lawsuits, four of which have been combined into one. The combined case is expected to be heard in Travis County district court in October, 2012.
