A Summary of the July 18, 2011 Palestine ISD Board of Trustees Meeting

Construction Projects Update

Walt Wood of Claycomb Associates, Architects provided the Board of Trustees an update of the construction progress.

Overall, the Palestine ISD projects are 64% complete and 20.6 million of the 64 million bond has been expended. At Palestine High School, the demolition of the main building began last week and is approximately 30% complete. The new PHS gym is complete and work continues on the new auditorium, band hall, cafeteria, and classrooms. At A.M. Story Intermediate new flooring is being laid and new restrooms are under construction. Both of these projects are scheduled to be completed before school begins.

Financial Update

David Atkeisson, Director of Business Services, informed the Board of Trustees regarding District budget information. Mr. Atkeisson informed the Board regarding a budget template for the 2011-2012 budget that is currently being reviewed to help make projections for next year's budget. In 2011-2012, the District will receive approximately \$545,912 from Edu Jobs which will help with next year's budget short fall. The District will review its investment strategy this fall to ensure the greatest return possible on district investments. A budget workshop is scheduled for August 1, 2011 at 6:30 p.m. to discuss and plan the 2011-2012 budget.

Superintendent's Report

Interim Superintendent Marvin Thompson presented information regarding a grant opportunity through the Institute where Creativity Empowers Education Success (ICEE). ICEE Success is an arts and science initiative in which Palestine resident Lucinda Presley is the director. The ICEE Success program would provide students an opportunity to develop 21st century thinking skills including conceptual thinking, creative and critical thinking, collaboration, communication, and creative problem solving. Suzanne Eiben, Assistant Superintendent of Human Resources will provide more information regarding the program at a later meeting in which the Board will consider implementation of the arts and science initiative.

Mr. Thompson reported that a nurse position would be added for the 2011-2012 school year due to the Texas Department of Health no longer offering immunizations in Palestine. This will make it easier for parents to obtain the needed immunizations for their children.
